The main responsibility of Sykehusinnkjøp is to carry out procurements on behalf of all the Norwegian hospitals and health trusts. Sykehusinnkjøp also manages the agreements once established. Sykehusinnkjøp covers almost all areas of the specialist health service such as; IT equipment, medicines, medical-technical equipment, medical and administrative consumer goods and services such as temporary staff and travels. Sykehusinnkjøp leads the procurement projects in close collaboration with different groups of specialists.

On an annual basis, Sykehusinnkjøp manages agreements for approximately NOK 35 Billion.

Division west is responsible for all hospitals and pharmacies in Western Norway as well as national responsibility for ICT / Construction and Innovation.

Nysnø is a sovereign climate investment company, and is administered by the Norwegian Ministry of Trade and Industry.

Nysnø hired me during the summer of 2018 as part of the management team that established Nysnø.

Stavanger University Hospital is one of the country's six university hospitals. The hospital employ around 7,500 people and serves a population of 350,000 in the southern part of Rogaland, from Hjelmeland in the north to Sokndal in the south.

Stavanger University Hospital is a part of the Norwegian specialist health service. It has four primary areas of responsibility: patient care, research, education of health personnel and training.

As CFO, I was part of the management team and was responsible for the following departments: Accounting, Purchasing and Contracting, Finance, Payroll and Analysis department. In addition, I had management responsibility for the Project Director and associated Project Office.

Stavanger University Hospital is building a new hospital at Ullandhaug. I was part of the steering group for this project throughout my time at the hospital.

Stavanger University Hospital's turnover is about NOK 7.5 Billion

2009 – 2014 Ahlsell Norge AS (Stavanger)

Position: CFO and Deputy CEO

From February 2009 employed as CFO. From October the same year also permanent role as Deputy CEO.

Ahlsell is the leading Nordic distributor of installation products, tools and supplies addressing installers, contractors, facility managers, industry, energy companies and the public sector.

I was a part of the management of Ahlsell in Norway through both acquisitions, mergers and restructuring of the company and its subsidiaries.

During my period in Ahlsell, I was also hired as CFO of the sister company Ahlsell Oil and Gas AS (AOG), where I also served as chairperson and shareholder-elected board member. AOG had a turnover of about NOK 400 million. I was in charge of the process when Ahlsell sold AOG to Stream AS (part of the portfolio of Hitec Vision V).

Ahlsell's turnover is about NOK 4 Billion.

Ahlsell went through changing ownerships throughout my time in the company. First by Goldman Sachs and Cinven, then CVC Capital Partners before it was finally listed on the Stockholm Stock Exchange.

Ahlsell's headquarter is located in Stockholm, Sweden.

American Wunderlich acquired Securities SSB Securities in 2009 and later merged it with Obligo AS (offices in Oslo and Stockholm).

I choose to treat all of the above positions related to Telenor, OilCamp and RigNet together, as they are all part of the same career path.

Telenor Business Consulting hired me as a consultant in e-commerce in the autumn of 2000. I was soon engaged as a business developer in the newly started and wholly owned Telenor Company named OilCamp AS. The strategy for the company was to be Telenor's arm into the oil and gas industry. After a short period, my employment was transferred from Business Consulting to OilCamp. The company quickly built up a turnover of NOK 30 million, and I took on the responsibility for finance, accounting and operations. The focus in OilCamp went from e-commerce to delivering secure collaboration and communication solutions to the oil and gas industry. The main product/service was SOIL; Secure Oil Information Link, a closed private communication and collaboration network for the industry. Satellite and radio line services to rigs in the North Sea, was also a part of the service portfolio.

In 2003-04, Telenor chose to move away from its direct focus on the oil and gas industry. OilCamp AS was transferred to Telenor Venture. The company was to be restructured and prepared for sale by Telenor. I took on the responsibility of leading this restructuring and was promoted to CEO.

Following the restructuring process, we achieved higher turnover and a profit margin of about 30%. After establishing a subsidiary in Aberdeen, I was given the task of supporting a facilitator (Fondsfinans) in the sale of the company. Several potential buyers expressed their interest. The process closed in February 2006 when a colleague and I undertook a successful MBO (management buy out) in collaboration with Hitec Vision Private Equity fund III. Half a year after the sale, OilCamp merged with another Hitec company; RigNet Inc in Houston (USA). I continued to lead OilCamp AS as a separate subsidiary, and I supported RigNet's VP Europe and Africa by taking on the role as CFO for the region. After a short time, I took on the role as Vice President and General Manager of Europe and Africa. Thereafter I initiated the process of merging OilCamp's subsidiaries in the UK with RigNet UK. In Norway I planned and facilitated the merger between RigNet AS, OilCamp Holding and OilCamp AS. The new unit is called RigNet Europe AS. The merged company has branches in Stavanger, Aberdeen and Lagos (Nigeria) in the Europe and Africa division. The previously mentioned SOIL currently has over 200 customers in Stavanger and Aberdeen, and has also expanded to the United States.
